- GPT: Generative Pre-trained Transformer, LLM: Large Language Model
- OpenAI released ChatGPT 3.5 – and 1 million user subscribed in 5 days!
- You can use ChatGPT to quickly create content
 - Either from scratch (prompt) or from existing content
- Possible uses in Industry/Manufacturing
 - Quality Control
 - Predictive Maintenance
 - Supply Chain Optimization
 - Customer Service
- Be careful about confidentiality
 - If you use the public version, all our input might be accessible to others.

- What might have seemed to be a completely new technology, was a technology many companies was already working on:
 - Open AI: ChatGPT 4
 - Google: Vertex AI, PaLM 2, Bard, Sagemaker
 - Meta: Llama 2
 - Anthropic: Claude.AI
 - Stability.ai: Stable Diffusion
 - IBM: Watson X
 - ...
 - Tesla/X: Working on an AI platform
 - SAP: Coming soon
 - Apple: Working on their own AI platform



Prompt Engineering – A new profession / skill?

- Not yet a sought profession
- But accounts for a significant amount of social media posts, adds, and offers.
 - Part of the new Gig Economy

Using ChatGPT to create prompts for ChatGPT!

- Prompts started out as “being a little more specific than standard search”
- Software Engineers started looking at this
 - They had been creating specific search prompts to find code in code libraries
- Then prompts became conversational with the ChatGPT bot
 - Narrowing down the results as part of the conversation
- Now gotten to a new method of asking the AI to generate prompts to get the best results.

Quick examples of Brainstorming with ChatGPT

- 🌀 *Provide 10 new ideas related to [subject] based on these examples ...*
 - 🌀 ...
- 🌀 *Generate 5 potential headlines/titles about [subject] in the style of these examples ...*
 - 🌀 ...
- 🌀 *Suggest 3 creative prompts to get new ideas about [subject]*
 - 🌀 ...





Competitive analysis

- 🌀 *Analyze [website] and tell me what industry they work in and potential competitors*
 - 🌀 ...
- 🌀 *Analyze the competitors listed and provide strengths and weaknesses of each*
 - 🌀 ...
- 🌀 *Great, now I would like to know about how people think about these other brands. Give an overview of the reviews of each*
 - 🌀 ...
- 🌀 *What are some of the ways [Company] can differentiate in the industry and win more market share*
 - 🌀 ...





How about helping with e-mails

- ✿ write e-mail to bob, *tone conversational, spartan, use less corporate jargon*: Current sprint is full, can't take new requests, late adds are hard, plan better next time

Hey Bob,

Hope you're doing well! Just wanted to shoot you a quick update on our current situation here. The sprint is jam-packed with tasks, and we can't really take on any new requests right now.

Late additions to the sprint are turning out to be quite challenging for us to manage. It throws off our plans, and we end up scrambling to keep things on track.

So, it would be awesome if we could plan things a bit better next time around. By having a solid plan in place from the start, we can avoid getting overloaded and ensure a smoother workflow.

Anyway, just wanted to give you a heads up on where we stand. Let's chat more when we get the chance!

Ask ChatGPT to generate prompts to be used to generate content

🌀 *I need to create an engaging image for social campaign. I will use an AI image generator called MidJourney.*

I will provide you with my Instagram caption and a brief description of the image I want. You will provide me with 5 prompts for MidJourney.

Your prompts should each include at least 4 descriptive keywords as well as stating the time of day, type of camera, type of film, and post processing techniques.

Your responses should each include my brief description followed by your keywords separated by commas. Nothing else.

Do you understand?

🌀 Yes, I understand. Please provide me with your Instagram caption and a brief description of the image you want, and I'll generate 5 prompts for MidJourney as per your requirements.

🌀 Caption: **Manufacturing is no longer dull, dark or dirty**

Image: **Bright manufacturing environment with diverse people interacting with machine**

MATURITY OF GENERATIVE AI



Still a new technology with some caveats


- Most solutions share data between all users
 - Concern for users to submit potential sensitive information into the system
- OpenAI and other systems has been trained with broad data sets
 - Including copyright and trademarked material
 - Some lawsuits has already been filed
- Complex interactions with the Chatbots can generate “Hallucinations”
 - Some answers are incorrect or misleading ... or even gibberish
 - These systems are constantly evolving with more information fed to them
- Always remember ChatGPT “makes stuff up”
 - Analyses the question and generate a reasonable response based on all the material used to learn.

Be careful with sensitive data

- Without your own instance or true firewalled solutions, you are sharing all your input with everyone else.
 - Your input is used to continuously improve the model
 - Although not directly accessed, it can be part of a response someone else asked for.
 - Use the tools for general research and responses
 - Don't have it analyze your internal financials or other sensitive data
- Look for solutions that offer separations between yours and other's data!

Some concerns about copyright and privacy

- Several Lawsuits has already been filed:
 - Sarah Silverman – Copyright
 - Privacy Class Action
- These are focused against:
 - OpenAI
 - Meta
 - Microsoft, etc.


Individuals should be protected against using the technology

Hallucinations!

- Image generating tools have been known to hallucinate
 - People with 6 fingers, three arms, etc.
- Early access to ChatGPT showed some interesting responses with long conversations:
 - One conversation had ChatGPT respond that the user “didn’t like them”
 - One conversation had ChatGPT make up statements from key white house officials.
- Generative AI rarely will answer “I don’t know”, instead it makes up stuff!
 - Incomplete or Biased training
 - Lack of context or understanding of the conversation
 - AI’s has not yet reached the level of Human language or communication

Need to look at policies around AI within organization

- Small, Medium or Large – Need to create policies around this area

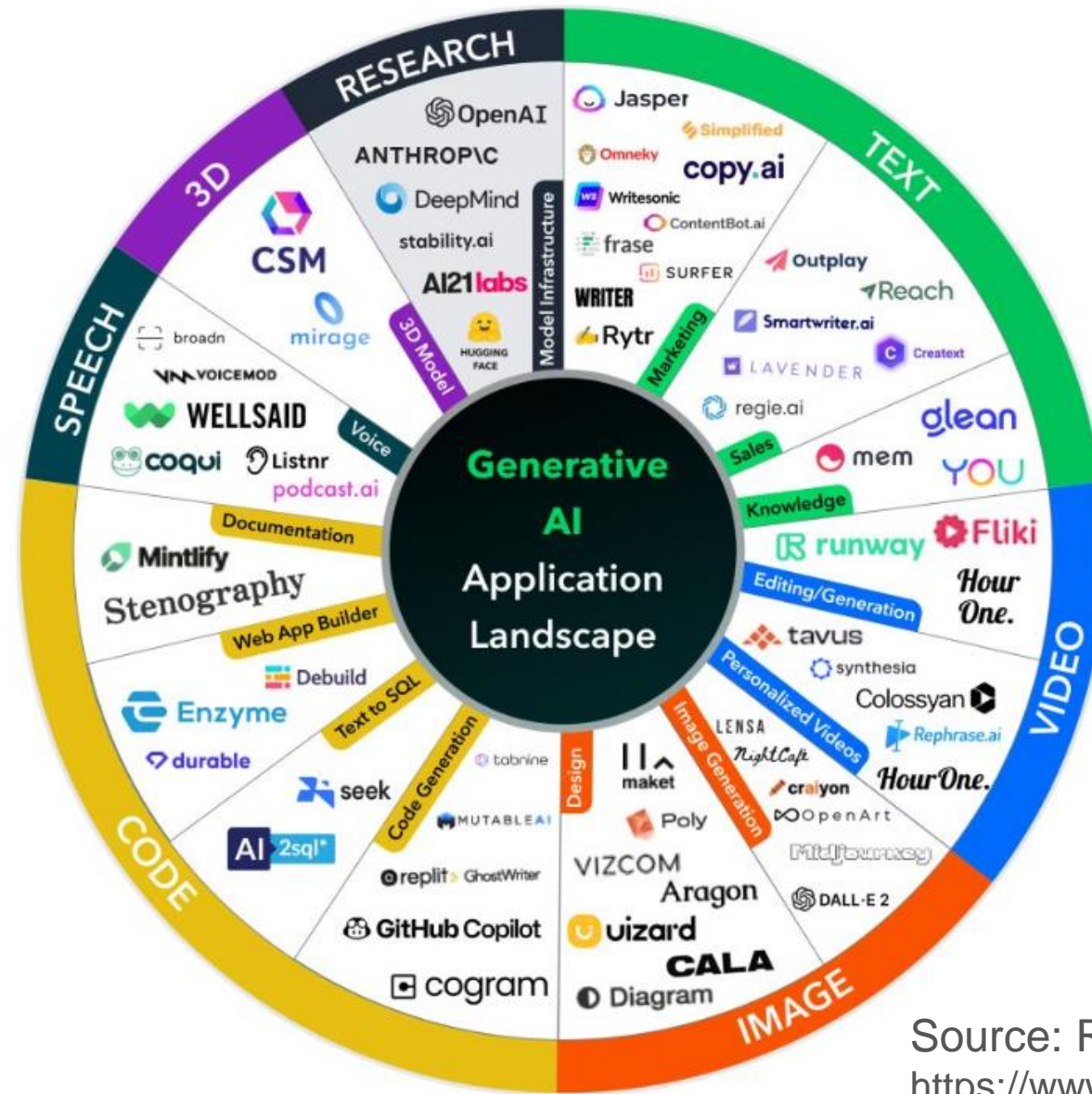

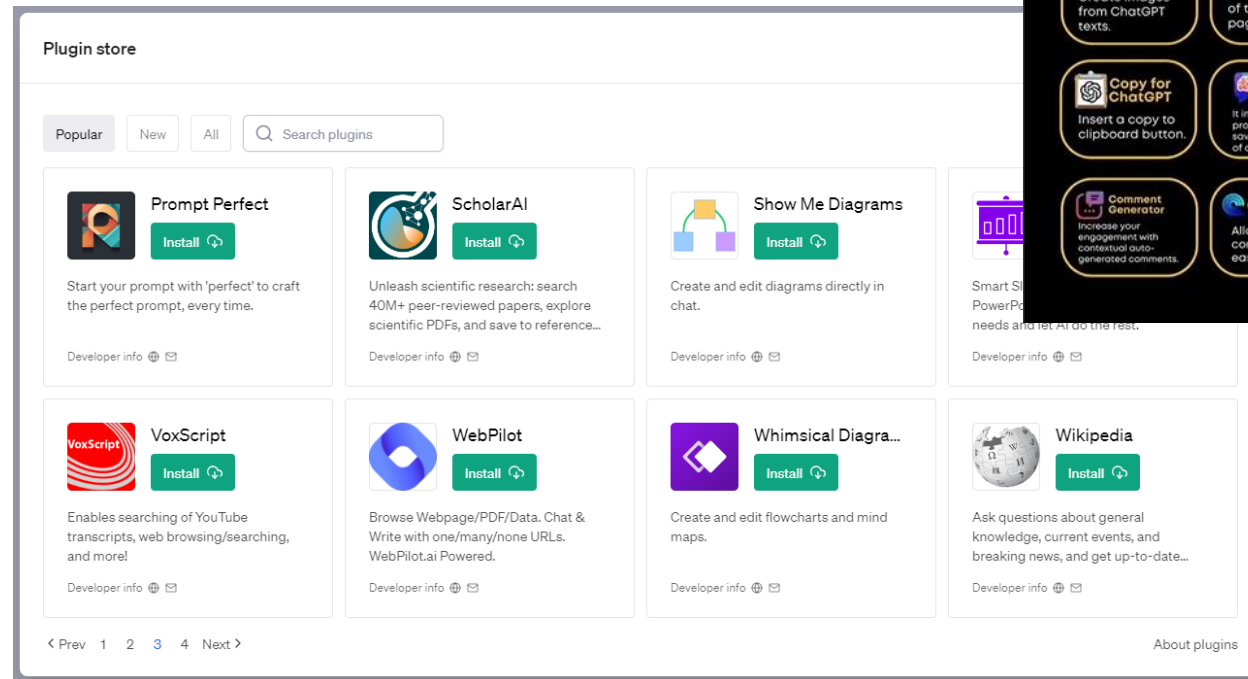
