Company becomes an importer



Shipping made easy: Many times, when products are sold or ordered moved via some integrated service it is forgotten when crossing over international borders it is important to follow many regulations.

- Domestic movements are fluid
- Canada is fairly easy
- As we dip into trading from one country to the next the processes are not cookie cutter

Regulation are important even on the first shipment:

- Client says: But I just imported one time!
- Customs says: One time makes you an importer

Basic definitions:

- Importer: The company placing the product in motion to cross the international border
- Importer of Record: The company taking responsibility to clear goods through Customs
- PGA importer: The company taking responsibility to clear goods through the PGA

Importer of Record CF 5106

- The Importer of Record must have an official address on file with CBP.
 - This address will be used by CBP to send notices, communication, refunds, bills, liquidation notices, requests for information and other types of communication.
- Verify your name and address
- This address may have been “keyed in” on the first import and never updated.

- The Surety who writes your bond will also require updates to your name and address
 - Adding name and addresses
 - Adding drop locations owned by your company

Bond Requirement CF 301

- CBP requires Entry is bonded by the IOR.
- Standard Continuous Bond:
 - \$500,000 in duties annually
 - 10% of the total duties annually
 - \$50,000 bond min.
- Standard Single Transaction Bond:
 - Covers Each shipment independently based on the value of goods + duties
 - PGA REQUIRES X 3
- Each Bond is covered by a Surety. Surety makes final decision to take the risk

Right to make entry



- The importer of record has to right to make entry on their own behalf.
- Only 3% process their own entries



- The Importer may hire a Licensed Customs Broker (a specialist in import regulations and is authorized by CBP to transmit via ACE)
- A Power of Attorney is required
- Do you have a compliance relationship with your broker?
- Are you showing Reasonable Care?

Integrated Carrier



- Handles international & domestic cargo movement.
- They use their own equipment, leased equipment and agents to offer efficient logistics for small items and documents



- Good for small, low value, simple cargo (non pga)
- Can also function as a Customs Broker when authorized
- Fast if simple, but can be difficult to control the data elements

Constraints in moving a shipment via an integrated carrier?

- **Length/Weight:** The length and width go beyond the standard requirements of the provider.
 - UPS: 108 inches long, 165 inches in length and girth combined / 150 lbs
 - FedEx: 119 inches long and 165 inches in length and girth. / 150 lbs
 - DHL: 240x120x220 cms (95x48x87 inches) / 154.3 lbs
- **Dangerous goods:** the shipper will be limited to the size, and type of dangerous goods.
- **Value:** Many integrated carriers have a maximum value per package of
 - UPS has reported a maximum of \$50,000.00
- **De minimis value:** The value is beyond the customs authority de minimis and requires an entry.
 - Frequency may push you over the de minimis.
 - China's de minimis removed (May 2nd)
 - Rest of the world \$800
- **Regulatory requirements:**
 - Products that require specific regulatory requirements beyond a basic customs processing may be stopped and sent back to origin

Basic documents required for a product imported

- Transport document Bill of lading / Air Waybill
 - Commercial invoice (proforma if a no – sale)
 - Packing list (optional) but very useful
 - Certificate for particular program or statement (FTA, Product details, PGA)

Commercial invoice details

- **Name and address of buyer and seller**
 - **Invoice number and date**
 - **Merchandise Description:** Common name, quality, marks/numbers, and packaging info.
 - **HTSUS:** first six digits (at least)
 - **Quantities:** In appropriate weights and measures. (PACKING LIST OPTION)
 - **Incoterm**
 - **Purchase Price:** Price paid or payable
 - Alternate Valuation (if not sold): Estimated value based on typical wholesale pricing.
 - **Currency**
 - **Charges:** Freight, insurance, commissions, packing, etc., itemized
 - **Assists/Rebates/Drawbacks/Bounties:** Separately itemized if applicable.
 - **Country of Origin:** Of the goods.



4. For the purposes of heading 9406, the expression "prefabricated buildings" means buildings which are finished in the factory or put up as elements, entered together, to be assembled on site, such as housing or worksite accommodation, offices, schools, shops, sheds, garages or similar buildings.

Prefabricated buildings include "modular building units" of steel, normally presented in the size and shape of a standard shipping container, but substantially or completely pre-fitted internally. Such modular building units are normally designed to be assembled together to form permanent buildings.

6. For purposes of heading 9406, the unit of quantity, m², refers to the floor area of the building when assembled.

Definition of Prefabricated Building

2. The articles (other than parts) referred to in headings 9401 to 9403 are to be classified in those headings only if they are designed for placing on the floor or ground.

The following are, however, to be classified in the above-mentioned headings even if they are designed to be hung, to be fixed to the wall or to stand one on the other:

- (a) Cupboards, bookcases, other shelved furniture (including single shelves presented with supports for fixing them to the wall) and unit furniture;

 - (a) In headings 9401 to 9403 references to parts of goods do not include references to sheets or slabs (whether or not cut to shape but not combined with other parts) of glass (including mirrors), marble or other stone or of any other material referred to in chapter 68 or 69.
 - (b) Goods described in heading 9404, entered separately, are not to be classified in heading 9401, 9402 or 9403 as parts of goods.

For the purposes of heading 9406, the expression "**prefabricated buildings**" means buildings which are finished in the factory or put up as elements, entered together, to be assembled on site, such as housing or worksite accommodation, offices, schools, shops, sheds, garages or similar buildings.

Statistical Notes

1. In heading 9401, stationary activity centers do not have castors or wheels.
2. For the purposes of statistical reporting number 9403.20.0075, the term "boltless or press-fit steel shelving units prepackaged for sale" refers to steel shelving in which the steel vertical and horizontal supports lock together to form the frame for the shelving unit and are assembled primarily without the use of nuts and bolts or screws. Boltless steel shelving includes rivet shelving, welded frame shelving, slot and tab shelving, and punched rivet (quasi-rivet) shelving but does not include wall-mounted shelving or wire shelving units in which a wire deck and wire horizontal supports are integrated into a single piece.
3. For the purposes of statistical reporting number 9403.20.0078, "metal exchange lockers" are lockers with individual locking doors mounted on one master locking door to access multiple units used by commercial businesses, hospitals, police departments, condominiums, apartments, hotels, automobile dealerships, etc.
4. For purposes of heading 9406 the unit of quantity, m^2 , refers to the floor area of the building when assembled.

Compiler's Note

The provisions of subchapter II of chapter 99 (Miscellaneous Tariff Bills or MTBs), the provisions of the Generalized System of Preferences (GSP) found in General Note 4 and most product exclusions from the additional tariffs on products of China in subchapter III of chapter 99 expired on December 31, 2020. 

3 Rates of Duty. The rates of duty in the "Rates of Duty" columns designated 1 ("General" and "Special") and 2 of the tariff schedule apply to goods imported into the customs territory of the United States as hereinafter provided in this note:

(a) Rate of Duty Column 1.

(i) Except as provided in subparagraph (iv) of this paragraph, the rates of duty in column 1 are rates which are applicable to all products other than those of countries enumerated in paragraph (b) of this note. Column 1 is divided into two subcolumns, "General" and "Special", which are applicable as provided below.

(ii) The "General" subcolumn sets forth the general or normal trade relations (NTR) rates which are applicable to products of those countries described in subparagraph (i) above which are not entitled to special tariff treatment as set forth below.

(iii) The "Special" subcolumn reflects rates of duty under one or more special tariff treatment programs described in paragraph (c) of this note and identified in parentheses immediately following the duty rate specified in such subcolumn. These rates apply to those products which are properly classified under a provision for which a special rate is indicated and for which all of the legal requirements for eligibility for such program or programs have been met. Where a product is eligible for special treatment under more than one program, the lowest rate of duty provided for any applicable program shall be imposed. Where no special rate of duty is provided for a provision, or where the country from which a product otherwise eligible for special treatment was imported is not designated as a beneficiary country under a program appearing with the appropriate provision, the rates of duty in the "General" subcolumn of column 1 shall apply.
